

TERMS AND CONDITIONS FOR REDEMPTION OF VicFalls COIN (VFC)

1. USING YOUR DISCOUNT DIGITAL TOKEN (dates and Partners to be announced)

- 1.1 These terms and conditions (together with any relevant documents referred to in them (including on the Website) set out the terms relating to the redemption of VicFalls Coin. Please note that the standard terms and conditions of the seller apply in respect of any orders placed using VFC.
- 1.2 By approaching a Business Partner of the VFC project and producing VFC, you are accepting these terms and conditions. Any terms which any VFC holder seek to impose in respect of the order in exchange for a discount will not form part of any contract between the Business Partner and issuers of the token. Please read these terms and conditions carefully before proceeding with your order. If you have any queries on these, terms please refer to the issuer of the token before attempting to use the VFC.
- 1.3 To the extent that there is any conflict or inconsistency between these terms and conditions and any other policy, the following order of precedence will apply:
 - Business partner terms and conditions of sale
 - VFC discount terms and conditions;
 - If used online-Website, terms of use;
- 1.4 We recommend that you print a copy of these terms and conditions for your future reference.

2. TERMS RELATING TO THE REDEMPTION OF DISCOUNT VOUCHER

- 2.1 Only one VFC can be used per order or product.
- 2.2 You cannot use a VFC in conjunction with any other sales discounts or promotional offers unless the specific terms relating to that promotion state that you can combine the VFC with other offers or by agreement with the service/product provider.
- 2.3 Generally, VFC can only be used for one order.
- 2.4 Acceptance of VFC by a Business Partners is subject to availability of goods and services offered at the time of purchase.
- 2.5 The VFC token does not entitle the holder to cash redemption value at the point of sale.
- 2.6 The Business Partner's terms and conditions of sale apply in respect of any orders placed using VFC and the VFC website terms of use may also apply.
- 2.7 Our Business Partners reserve the right to vary or discontinue the discount scheme at any time.

3. RIGHT TO VARY THESE TERMS AND CONDITIONS

- 3.1 The VFC Project and it's Partners have the right to revise and amend these terms and conditions from time to time including to reflect changes affecting our Business Partners, changes in technology, changes in payment methods, changes in relevant laws and regulatory requirements and changes in our website's capabilities.
- 3.2 VFC holders will be subject to the policies and terms and conditions of sale in force at the time that they use VFC, unless any change to those policies or these terms is required to be made by law or governmental authority (in which case it will apply to orders)
